Description: This safety recall involves the front passenger seat occupant detection mat. Depending on seat configuration and vehicle geometry, the mat can fatigue during field usage depending on the manner and frequency of the front passenger's entry and exit. Specifically, over time micro-cracks could develop in the side flanks of the mat. If a micro-crack leads to a break of a conductive path, the system will recognize a failure. Consequently, the front passenger air bags with the exception of the head protection system will be deactivated.

In a crash of sufficient severity, the front passenger air bags may not deploy, increasing the risk of injury.

Remedy: BMW will replace the front passenger seat occupant detection sensor mat. Final owner notification letters are being mailed on a staggered basis as parts become available.

Description: This recall involves an engine component known as the Positive Crankcase Ventilation (PCV) valve heater. The PCV valve heater may not have been produced to specifications. Over time, it could deteriorate and, in rare cases, could lead to overheating.

If overheating occurs, then in rare cases, this could lead to melting of the PCV valve. In extremely rare cases, this could lead to a fire.

Remedy: The PCV valve heater will be inspected and a new part will be installed. If necessary, additional components will be replaced as determined at the time of repair. All final owner notification letters have been mailed.

Glossary
